मुख्यमंत्री आदित्यनाथ ने आरएसएस प्रमुख मोहन भागवत से मुलाकात की

लखनऊ, 18 फरवरी (भाषा)।

मुख्यमंत्री योगी आदित्यनाथ ने बुधवार शाम राष्ट्रीय स्वयंसेवक संघ (आरएसएस) मोहन भागवत से मुलाकात की। संघ के शताब्दी वर्ष के तहत अपने लखनऊ दौरे के दूसरे दिन भागवत राजधानी में रहे। बुधवार रात करीब आठ बजे आदित्यनाथ उनसे मिलने निराला नगर स्थित सरस्वती शिशु मंदिर पहुंचे। दोनों के बीच लगभग 40 मिनट तक बैठक हुई, लेकिन इसका एंजॉडा सार्वजनिक नहीं किया गया है। हालांकि, भागवत द्वारा लगातार हिंदू एकता पर जोर दिए जाने के मद्देनजर इस बैठक को महत्वपूर्ण माना जा रहा है, क्योंकि यह मुख्यमंत्री के हालिया भाषणों के सुर से मेल खाता है जिनमें उन्होंने प्रोब्रह्मी समाजवादी पार्टी के 'पीडीए अभियान' का जिक्र किया है। भागवत जनवरी में 10 दिन के दौरे पर मथुरा गए थे। इसी महीने वह फिर उत्तर प्रदेश आए और अपने कार्यक्रम की शुरुआत गोरखपुर के तीन दिवसीय दौरे से की, जिसके बाद वह लखनऊ पहुंचे। आरएसएस इसे शताब्दी वर्ष के जनसंपर्क अभियान का हिस्सा बता रहा है, जबकि राजनीतिक जानकारों का मानना है कि 2027 के विधानसभा चुनाव से पहले इन बैठकों का राजनीतिक महत्व भी है।

अपर सत्र न्यायाधीश-04 की अदालत ने अपनी मां की चाकूओं से गोदकर हत्या करने के दोषी को सश्रम आजीवन कारावास की सजा सुनाई है। अदालत ने दोषी पर 50 हजार रुपए का अर्थदंड भी लगाया है, जिसे अदालत ने करने पर उसे चार माह का अतिरिक्त कारावास भुगतान होगा। जिला अदालतों में आपराधिक मामलों की पेशी की नौडल अधिकारी और पुलिस अधीक्षक ग्रामीण (दक्षिणी) अशिका वर्मा ने अदालत की ओर से मंगलवार को दिए गए फ़ैसले की जानकारी देते हुए बताया कि मामले की प्रार्थमिकी 18 अक्टूबर 2022 को थाना किला में दर्ज कराई गई थी। इसमें कहा गया था कि शराब के नशे में सूरज ने अपनी मां को चाकू मारकर घायल कर दिया। अस्पताल ले जाते समय रास्ते में उनकी मौत हो गई। अभियोजन पक्ष की ओर से इस मामले में 14 गवाह पेश किए गए। साक्ष्यों और गवाहों के बयानों के आधार पर अदालत ने आरोपी सूरज को दोषी करार देते हुए सश्रम आजीवन कारावास और अर्थदंड की सजा सुनाई है।

एनजीटी का हिंडन नदी के डूब क्षेत्र के सर्वेक्षण का आदेश

सहारनपुर, 18 फरवरी (जनसत्ता)।

राष्ट्रीय हरित प्राधिकरण (एनजीटी) ने आदेश दिया है कि सहारनपुर की हिंडन नदी के डूब क्षेत्र का सर्वेक्षण किया जाए। इसके लिए तीन करोड़ रुपए की राशि तय की गई है और पचास लाख रुपए संबंधित विभाग द्वारा जारी किए गए हैं। जानकारी के मुताबिक सर्वे के दौरान अत्याधुनिक मानचित्रण तकनीक और जीआइएल डाटा का उपयोग कर हिंडन नदी की वास्तविक सीमा, जलप्रवाह क्षेत्र और संभावित डूब क्षेत्र की पहचान की जाएगी और फिर निर्धारित स्थानों पर खंभे लगाए जाएंगे। जिससे इस नदी क्षेत्र पर अतिक्रमण को रोका जा सके। इससे पूर्व सोनाली नदी के बाढ़ क्षेत्र का निर्धारण कर सीमांकन खंभे लगाए जा चुके हैं। सिंचाई विभाग के अधीक्षण अभियंता रामबाबू ने बुधवार शाम को बताया कि अब हिंडन नदी के डूब क्षेत्र का चिन्हीकरण का काम सर्वे आफ ड्रिडिंग द्वारा कराया जा रहा है और सीमा निर्धारण के बाद सिंचाई विभाग द्वारा खंभे लगाए जाएंगे।

जनपद में माध्यमिक शिक्षा परिषद उग्र प्रयागराज की हाईस्कूल एवं इंटरमीडिएट बोर्ड परीक्षा बुधवार, 18 फरवरी से प्रारंभ हो गई। पहले दिन दोनों पालियों में हिंदी विषय की परीक्षा शांतिपूर्ण एवं नकलविहीन वातावरण में सम्पन्न हुई।

प्रथम पाली में हाईस्कूल की हिंदी विषय की परीक्षा आयोजित की गई, जिसमें कुल 31,715 परीक्षार्थी पंजीकृत थे। इनमें से 29,429 परीक्षार्थी उपस्थित रहे, जबकि 2,286 अनुपस्थित पाए गए। इसी प्रकार द्वितीय पाली में इंटरमीडिएट की हिंदी एवं सामान्य हिंदी विषय की परीक्षा संपन्न हुई, जिसमें कुल 32,040 परीक्षार्थी पंजीकृत थे। इनमें 30,636 परीक्षार्थी उपस्थित रहे तथा 1,404 अनुपस्थित रहे। शासन की

'प्रदेश में 3.26 करोड़ मतदाताओं को भेजे गए पुनरीक्षण नोटिस'

लखनऊ, 18 फरवरी (भाषा)।

उत्तर प्रदेश के मुख्य निर्वाचन अधिकारी नवदीप रिणवा ने बुधवार को कहा कि विशेष गहन पुनरीक्षण (एसआइआर) के तहत 3.26 करोड़ मतदाताओं को नोटिस भेजे गए हैं और उन्होंने भरोसा दिलाया कि सिर्फ नोटिस न मिलने की वजह से किसी भी मतदाता का नाम सूची से नहीं हटाया जाएगा।

रिणवा ने एसआइआर की हालिया प्रगति का ब्योरा देते हुए नोटिस, विसंगतियों की पहचान करना और नाम जोड़ने-हटाने में इस्तेमाल होने वाले फार्म-छह और फार्म-सात से जुड़े मुद्दों को स्पष्ट किया। यहां एक संवाददाता सम्मेलन में उन्होंने बताया कि जिन मतदाताओं के रिकार्ड में 'नो मैपिंग' या तार्किक विसंगतियां पाई गईं उन्हें

नोटिस भेजे गए हैं। उन्होंने कहा कि जिन मतदाताओं के नाम मसविदा सूची में थे, उन्हें नोटिस भेजे गए। इनमें से 1.04 करोड़ मतदाताओं ने पिछली एसआइआर के दौरान संबंधित कालम खाली छोड़ दिया था और मतदाता सूची की 'मैपिंग' पूरी नहीं की थी, जबकि 2.22 करोड़ के रिकार्ड में तार्किक गड़बड़ियां थीं। उन्होंने बताया कि 1.85 करोड़ नोटिस वितरित किए जा चुके हैं और 1.15 करोड़ मामलों में सुनवाई पूरी हो चुकी है। रिणवा ने कहा कि पांच फरवरी तक केवल 30 लाख सुनवाई हुई थीं। 18 फरवरी की सुबह तक यह संख्या 1.15 करोड़ पहुंच गई और पिछले तीन दिनों में ही करीब 37 लाख सुनवाई पूरी हुई। उन्होंने भरोसा जताया कि सभी सुनवाई 27 मार्च की तय समयसीमा के भीतर पूरी हो जाएंगी।

पुलिस के अनुसार जटहां बाजार थाना क्षेत्र के कंठीछपरा गांव के सिंहासन प्रसाद कामगार के रूप में वर्तमान में गुरात में कार्य कर रहे हैं। घर पर उनकी पत्नी मूरती देवी सुबह लगभग 11 बजे अपने मोबाइल की बैटरी

निकाल कर घर में लगे सोलर चैनल से चार्ज करने के लिए जुगाड़ से तार से जोड़ा था। वहीं टिनशेड के नीचे अपनी तीन वर्षीय बच्ची सृष्टि के साथ बैठी हुई थी। कुछ देर बाद अचानक बैटरी ब्लास्ट के साथ बच्ची के सिर पर आ गिरी। सिर में गंभीर चोट आई। परिसर में मेडिकल कालेज कुशीनगर ले आए तो डाक्टरों ने प्राथमिक उपचार के बाद गोरखपुर मेडिकल कालेज अस्पताल रेफर कर दिया। वहां उपचार के दौरान कुछ देर बाद मृत्यु हो गई। इस संबंध में जटहां बाजार थानाध्यक्ष आलोक यादव ने बताया कि पुलिस ने शव को बरामद करते हुए पोस्टमार्टम के लिए भेज दिया है। अग्रिम कार्यवाही की जा रही है।
